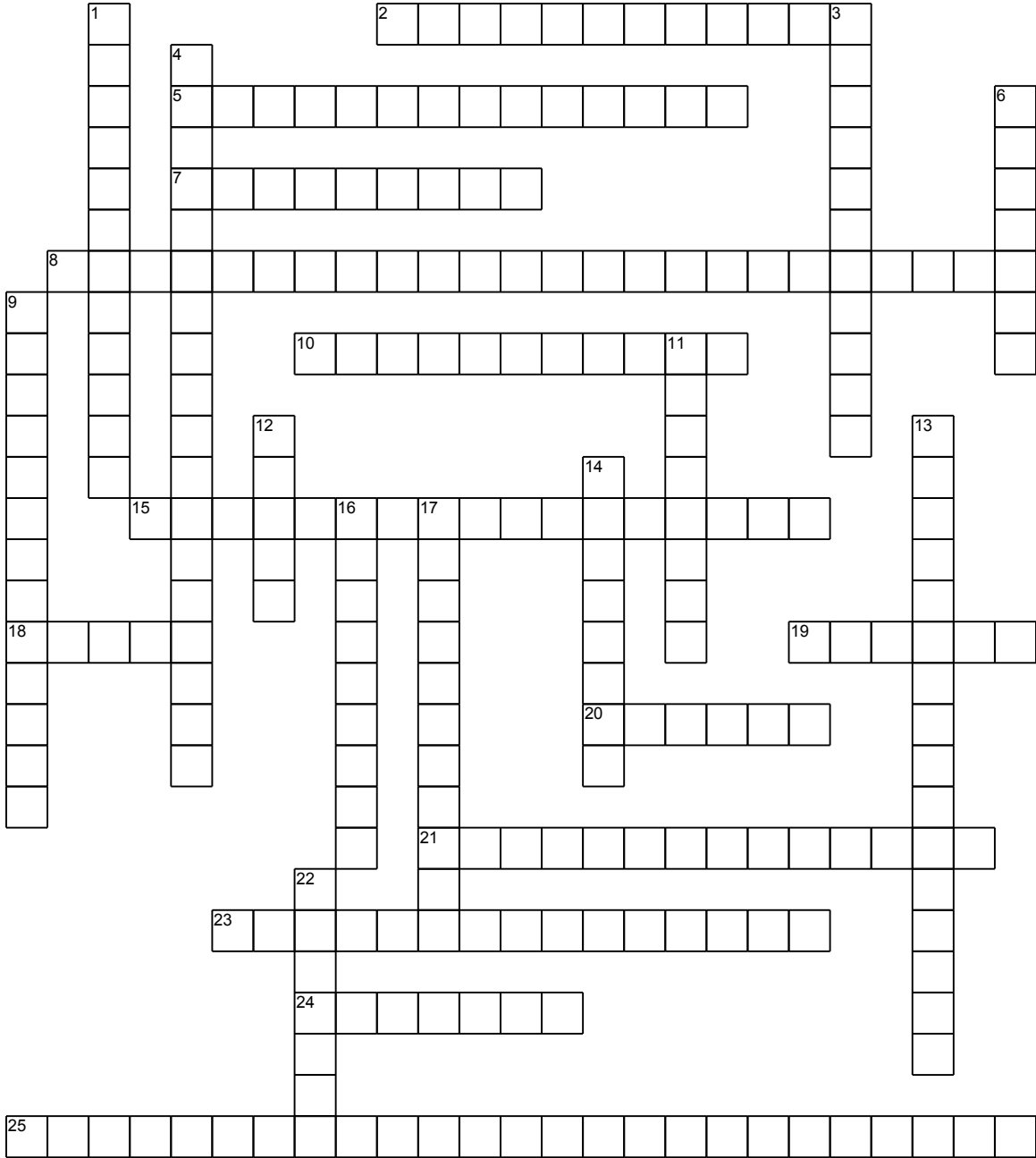

- 5. 1809-1865, Congressman from Illinois who became the sixteenth President of the United States, 1861-1865. He led the Union during the Civil War.
- 7. A town in Oklahoma that was founded by Cherokee forced to leave the Southeast.
- 8. The announcement by President Lincoln in 1863 that all enslaved people living in Confederate states were free.
- 10. The government formed by 11 Southern states that seceded from the United States, 1860-1865.
- 15. 1817-1895, Abolitionist, writer, and speaker.
- 18. The states that remained in the United States after the Confederacy formed.
- 19. A place that is ruled by a distant ruler.
- 20. Cherokee capital in the 1700s, near what is now the North Carolina-Tennessee border.
- 21. The use of advanced scientific ideas and special tools to meet people's needs.
- 23. 1743-1826, Member of Virginia House of Burgesses who drafted the Declaration of Independence. He became the third President of the United States, 1801-1809.
- 24. A group of people who meet to talk and make decisions.
- 25. A document written by Thomas Jefferson in 1776 explaining why the 13 colonies should be free of British rule.

- 16. 1913-2005, Civil rights activists whose arrest led to the Montgomery, Alabama, bus boycott.
- 17. The rights of people to be treated equally under the law.
